215. Discuss public complaints regarding parking and speeding in Bere Alston

The Clerk read out three emails received from concerned residents:

1. A resident living on the Down raising concerns about speeding and poor parking, and noted the absence of speed limit signs.

Cllr. Maycock advised that where street lighting is present the speed limit is automatically 30 mph. It was noted that the road becomes particularly busy on football match days, but there are currently no parking restrictions in place. The Council agreed to again ask the Adult and Junior Football Team managers to remind visitors not to speed and to park more considerately.

2. A resident asking if anything can be done about the parking around the Lockeridge road junction opposite the fire station? As it has become increasing difficult to avoid an accident when as a driver you cannot see left or right when pulling out due to the cars and vans blocking the view.

A member of the public present at the meeting, also raised concerns regarding vehicles being parked too close to the junction of Lockeridge Road and Station Road. They also highlighted that drivers are speeding around the corner of Tap Hill. Cllr. Maycock suggested that the Parish Council write to Devon Highways, copying in Cllr. Fife Cook, to highlight that these areas are accidents waiting to happen and to ask what possible measures to address the issues could be considered.

Discussions took place between a member of the public and Councillors regarding speeding on Station Road. The member of the public again asked about the proposal to install speed bumps. Cllr. Patterson confirmed that the school had not made an application for speed bumps. Instead, the school was hoping to have a flashing 20 mph sign installed, which they hoped would be funded and implemented by Devon Highways.
